Orson Wells is quoted to have said, "The enemy of art is the absence of limitations." Thinking outside of the box is easy, creating inside one takes talent. A native of the City of Atlanta, Fulton County, Antonio began his career with the United States Marine Corps in 1990 as an Aircraft Firefighter and Rescue Specialist. He proudly served our Nation and received the national defense medal for Operation Desert



Storm; most notably trained and certified as a space shuttle orbiter trainee. In April of 1994, he joined the DeKalb County Fire Rescue Department. During his tenure he has held all ranks within the Department: Firefighter, Driver Engineer, Paramedic, Lieutenant, Captain, Fire Rescue Captain, Battalion Chief, Fire Marshal, Assistant Chief, Chief of Staff and Deputy Chief. As a Firefighter, Antonio quickly excelled and achieved the rank of lieutenant; his leadership style and command presence led to an immediate station officer assignment. As an ambassador of the department, Antonio noticed the directional shift towards cross training and took the initiative to obtain a paramedic certification. After successful completion of the course, he immediately achieved the rank of Captain. Having served as an Honor Guard Member since 1996, Antonio assumed the duties of Captain of the Guard and eventually Honor Guard Commander, where he proudly serves today. As a

Captain, Antonio proudly assisted the accident review board. Effectively identifying risk factors that lead to departmental losses, while working to promote and implement industry best practices. Antonio has mentored others, in part by serving as a subject matter expert and assisting with design and implementation of departmental testing procedures for various ranks throughout the country. He willingly served on oral review panels for new hires, ensuring the integrity of the hiring process and quality of the applicants recommended. As Battalion Chief, he worked as a key member of the management staff, responsible for managing day to day operations. He coordinated emergency responses and managed fire crews both large and small, supervising Captains who handle individual groups of firefighters. Equipped with an advanced knowledge of fire theories, principles and techniques, he excelled in applying that knowledge in real time to assist in mitigating emergencies.

While appointed as the Fire Marshal, he implemented, managed and directed DeKalb County Fire Marshal fee structure in accordance with State Law. The implementation of the first ever DCFR Fire Marshal fee program continues to generate millions of dollars in revenue for the fire fund. Among his numerous achievements, he actively worked with DeKalb County School District to implement the system's first innovative approach to school fire protection through Carbon Monoxide systems. He also partnered to successfully obtain over \$10 million dollars in SPLOST funds to provide much needed improvements to DCSD's handicap accessibility. He assisted with the development of the DeKalb County ADA Transition Plan and led the department in a review of all Fire Rescue buildings, as it pertains to ADA. This initiative included a comprehensive review of conditions and recommendations for improvements.

Antonio currently has the honor of serving as Deputy Chief of Professional Services and Community Risk Reduction. He has management and oversight responsibilities in multiple areas: The Fire Marshal's Office, Human Resources, Personnel Office, Appraisal and Planning, the Fiscal Office, E911 Communications Group and Internal Affairs. The Fire Marshal's office is responsible for Fire Investigations, Fire Inspections and Public Education. This office works daily across the County to educate internal and external stakeholders to create a safer DeKalb. Human Resources handles employee

relations and compliance with local and State regulations. Personnel office handles employee payroll and personnel services. The newly formed Appraisal and Planning Group introduces data analytics to the Fire department, incorporating data driven decision making, ISO compliance, effectively moving the department towards Accreditation through the Center for Public Safety Excellence. E911 Communications Group works with local PSAP's to ensure top notch industry best practices and programs are implemented. On October 6, 2020, Nurse Navigator program went live for DeKalb County, marking the first of its kind in the State of GA. This program provides Nurse interaction with E911 callers through the warm transfer of low acuity calls, assisting citizens with access to alternative forms of care. Under the Professional Service umbrella, he partners with DeKalb County Law Department to facilitate all contractual services. He develops Fire Rescue agenda items for DeKalb County Board of Commissioners and fills in for the Fire Chief in his absence as DCFR responds to over 80,000 service calls annually. He also provides oversight of the Fiscal Office, which develops and manages DCFR's \$69+ million-dollar budget. Additionally, he works to fulfill the Fire Department's fiduciary responsibility by obtaining and managing over \$15 million dollars in grant funding.

His educational experiences consist of an Associate's Degree of Applied Science-Paramedic Technology (2010), Nationally Registered Paramedic (2003), Executive Development Program Graduate (2005), P.O.S.T.
